### Libraries switch to curbside service

Mansfield/Richland County Public Library (MRCPL) has shut down facilities to the public and reverted to curbside service due to the rising number of COVID-19 cases.

Until further notice, MRCPL will no longer be open to the public and will revert to curbside service only at all nine locations. This went into effect Monday, Dec. 7.

Curbside service will be available Monday through Thursday, 10 am to 6 pm, Friday, 10 am to 5 pm, and Saturday, 10 am to 2 pm.

Additionally, lobby services at First Call 211 will move to curbside service only Monday through Friday, 9 am to 4 pm. The 24/7 2-1-1 hotline is always available to assist residents of Richland County.

"Out of an abundance of caution, we are closing our locations for walk-in service. After continuous conversation with Richland Public Health, we feel this is the best way to move forward as we prioritize the health and safety of our staff and community," said Chris May, library director.

"Any customers with materials already on hold can pick them up via convenient curbside pick-up at any of our locations. Customers may continue to request materials online or over the phone directly from their preferred branch. Wifi service remains accessible in all branch parking lots."

MRCPL encourages patrons to visit their website to take advantage of virtual programs, take-home craft kits for all ages and to utilize digital services.

# **Generous donors make Richland Gives a success**

Richland Gives, an online giving event hosted by the Richland County Foundation, raised \$356,820 for 83 Richland County nonprofit organizations. Since its inception in 2015, Richland Gives has raised \$1,435,869.

Richland Gives is designed to encourage contributions to local nonprofits through a single giving website. The foundation hosted the day to build capacity, grow philanthropy and make the community stronger. It allows local organizations to raise funds and awareness as well as cultivate new donors and reinvigorate lapsed donors.

The foundation awarded \$34,000 in grants as incentives during the giving event. The nonprofit organizations that raised the most in the small and large nonprofit category were awarded \$3,000, for first place, \$1,500 for second place and \$500 for third place.

Winners in the small nonprofit category with annual budgets under \$250,000 were first Lucas Community Center; second Little Buckeye Children's Museum; third North Central State College Foundation.

Winners of the large nonprofit category with annual budgets over \$250,000 were first Discovery School; second Renaissance Performing Arts; third Ohio Bird Sanctuary.

These following 15 organizations were the first to raise \$1,000 online and were awarded a \$1,000 matching grant: Altrusa, Ohio Genealogical Society, Plymouth Area Historical Society, North Central State College Foundation, Clear Fork Valley Foundation, Richland Pregnancy Services, Discovery School, Mid-Ohio Guardianship Services Inc., Ohio Bird Sanctuary, Friends of the Gorman Nature Center, Richland Academy of the Arts, Visual Bucket List Foundation, Lucas Community Center, Little Buckeye Children's Museum and North Central Ohio Industrial Museum.

The organizations awarded \$500 grants for raising the most money or having the most donors during Golden Ticket hours were: Lucas Community Center, Kingwood, TWO tickets to Richland Academy of the Arts, Boy Scouts of America, Buckeye Council, Salvation Army, Altrusa, Discovery School, Visual Bucket List Foundation and Renaissance Performing Arts.

Sixteen grant prizes worth \$250 each were awarded by a random drawing during the Leader Board Watch Party: Richland Academy of the Arts, Freedom Ridge, Humane Society of Richland County, Community Health Access Project (CHAP), Richland Pregnancy Services, Catholic Charities, Love our Hero's, NAMI, Mansfield Art Center, St. Mary of the Snows Catholic School, Idea Works Entrepreneurs Kitchen, Community Action Commission, Clear Fork Valley Foundation, Camp Nuhop, Love Inc. and Salvation Army.

Mank, directed by David Fincher who also made such great films as *The Social Network, Seven* and *Fight Club*, tells the story of the classic film *Citizen Kane* told

through its writer Herman J. Mankiewicz. He is played in another great performance by Gary Oldman, as the writer and is asked in the last years of his career and with his alcoholism at its height, to write what has become to many, the greatest film ever made.

Filmed in beautiful black and white, Fincher tells the main part of the story at a ranch in California after Mank, as he is known, suffers and injury and is mainly bed ridden writing this script

with the help of a secretary (Lily Collins). Much of this story is told through flashbacks of Mank's life at different points in Hollywood, his association with MGM head Louis B. Mayer (Arliss Howard) and becoming close friends with William Randolph Hearst's mistress (Charles Dance) Marion (Amanda Seyfried). Heart was the main inspiration for *Citizen Kane*.

Oldman is one of our greatest actors, winning an Oscar a couple years ago for brilliantly playing Winston Churchill in Darkest Hour. He gives Mank such charm,



wit and humor and shows a man who realizes he has the written the best thing in his career yet facing his own personal demons. Oldman and Seyfried are great in

their scenes together and much of this movie, from the opening to end credits, feels like something out of Old Hollywood.

Mank ended up being a movie that was more appreciated than loved. The movie was beautiful to look at and gave a lot of good history about the time in which it was set, including many elements that ended up inspiring *Citizen Kane*. The flashbacks took away at times from the forward movement of the story and were difficult a of

to keep track of.

Despite this, the movie was more engaging than not, had assured direction and great performances. This movie is more for people who are interested in this period in Hollywood and in the making of Citizen Kane itself but more casual viewers may get something out of it too.



Farm work is always labor-intensive. Cleaning manure out of a livestock barn was a most unpleasant chore for a man of the soil.

Bill Templeton came from a large farm in Pennsylvania and bought an old factory building on Plymouth St., in Lexington.

Although not an engineer, he was smart enough to design a hydraulic loader for farm tractors. It was just what farmers would need to clean out barns and perform other lifting chores around the farm.

Templeton didn't have much when he started. He didn't even have a tractor, so he borrowed one from the Furher Farm south of town.

Templeton was partnered with Jim Gorman when they were in the potato

where he met Furher. His self-designed loader caught on and

soon he was selling them all over Ohio and neighboring states.

Nineteen year-old Gene Wirick became the first salesman for Bill and traveled the country demonstrating and selling the loaders.

Bill's next design was a heavy-duty manure spreader. A few are still in service today, after more than 60 years.

The Allis Chalmers company offered a contact to build loaders which were painted Allis Chalmers orange. Bill refused the change (his were yellow) and they were sent elsewhere. That, and with a divorce from his wife who had owned the Pennsylvania farm money, ended the company sometime around 1954.

19 symptoms. Red Cross antibody tests will be helpful to identify individuals who have COVID-19 antibodies and may now help current coronavirus patients in need of convalescent plasma transfusions.

Convalescent plasma is a type of blood donation collected from COVID-19 survivors that have antibodies that may help patients who are actively fighting the virus.

COVID-19 antibody test results will be available within one to two weeks in the Red Cross Blood Donor App or donor portal at RedCrossBlood.org.

A positive antibody test result does not confirm infection or immunity. The Red Cross is not testing donors to diagnose illness, referred to as a diagnostic test. 

# FCC allocates over \$170 million to expand broadband access

U.S. Sen. Sherrod Brown applauded an announcement by the Federal Communications Commission (FCC) that it will invest \$170,038,205 to expand broadband access to more than 400,000 rural Ohioans. The FCC today announced the results of its auction of investments to companies that will expand access to broadband in Ohio, including rural and underserved communities that have long been pushing for greater broadband infrastructure.

Brown introduced legislation with Sen.

Rob Portman (R-OH) earlier this year, the Rural Broadband Acceleration Act, that would speed up the process of getting these types of investments from the FCC to Ohio communities faster.

"By expanding access to broadband internet, we can make it easier for Ohioans to make a living, learn online and keep in touch with loved ones," said Brown. "Especially now, amid the COVID-19 pandemic, connectivity is more important than ever. Today's announcement is good news for our state and our ability to remain connected."

In July, Brown introduced legislation to make sure Ohio students have reliable broadband internet during the COVID-19 pandemic.

Ohioans who live in low-income areas are too often at an economic and educational disadvantage due to little or no access to reliable broadband internet service. Addressing this disparity is critically important now when so many Ohio schools are announcing they will begin the school year with e-learning in place.







The Knox County Career Center Preschool has been awarded the Step Up to Quality (SUTQ) five-star rating for the sixth straight year from the Ohio Department of Education.

SUTQ is a five-star quality rating and improvement system administered by the Ohio Department of Education and the Ohio Department of Job and Family Services. SUTQ recognizes and promotes learning and development programs that meet quality program standards that exceed preschool licensing and school-age child care licensing health and safety regulations. SUTQ program standards are based on national research identifying standards which lead to improved outcomes for children.

All Early Childhood (ECE) and Preschool Special Education (PSE) programs funded by the Ohio Department of Education (ODE) are mandated to participate in SUTQ and are required to achieve a rating of 3, 4, or 5 to maintain state funding, as well as administer and report on the Early Learning Assessment for all ECE and PSE funded children.

Jeremi Jarosz, KCCC Preschool Director, said, "I am very grateful to an administration team who has supported the preschool and my staff in maintaining our five-star rating. There are many requirements that go into maintaining the highest level. We need to fulfill many requirements, including education of staff, smaller teacher to student ratios, ongoing education, utilizing specific curriculum, and completing the Early Learning Assessment." Jarosz added, "Every year we have to submit the required documentation. This year, we also had an onsite visit to make sure we are doing everything we say we do."

# CACY gives tips for preventing and dealing with cyberbullying

Many schools are virtual and youth are spending more time online for academics and interacting with their peers. This unprecedented time has the potential to increase cyberbullying behavior. Cyberbullying is using a form of technology to intentionally hurt or harm someone else.

Community Action for Capale Youth (CACY) has released some tips and information if faced with a cyberbullying problem.

#### What can parents do?

Start talking with your child about what cyberbullying is and how to handle if it happens to them or if they witness it. Keep the use of the computer in an open room where visible.

If your child is cyberbullied through online schooling, contact your child's school. If they are cyberbullied on a social networking site, check the site for ways to report/ block. Remind your child that they are not alone and together you will find a solution.

#### What can teachers do?

Always promote a respectful environment. Know the signs of cyberbullying and be on the lookout for them during virtual learning. Is the student with-drawing?

Are their grades suddenly dropping? Are they not joining live classes? Let students know it's okay to report this kind of behavior to you. Imple-ment the school's anti-bullying policies even in a virtual environ-ment.

#### What should students do?

If a student is being cyberbullied or witnesses it, encourage them to tell a trusted adult. If happening during school, reach out to the teacher. Take a screenshot or picture of the incident or save the messages to show an adult.

# **EQUIP deadline is January 15**

The U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) announced Friday, January 15, 2021, as the deadline to submit applications for Ohio's Environmental Quality Incentives Program (EQIP).

EQIP is a voluntary conservation program which helps producers make conservation work for them. NRCS provides agricultural producers with financial resources and one-on-one help to plan and implement improvements, or what NRCS calls conservation practices. Using these practices can lead to cleaner water and air, healthier soil and better wildlife habitat, all while improving agricultural operations. Through EQIP, you can voluntarily implement conservation practices, and NRCS co-invests in these practices with you. Together, NRCS and producers invest in solutions that conserve natural resources for the future while also improving agricultural operations.

Financial assistance is now available in a variety of agricultural categories such as cropland, pasture operations, and organic. Several special projects are also available which address water quality, forestry management, improving pollinator populations and wildlife habitat, pasture improvements and many more.

Applicants should be farmers, or farm or forest landowners and meet eligibility criteria. To participate in USDA conservation programs, contact your local NRCS conservationist as soon as possible. Be sure to check the status of your Service Center when you reach out to us. For offices with restrictions on in-person appointments, we are still available by phone, email, and through other digital tools. Your Service Center's status is available at https://www.farmers.gov/coronavirus/service-center-status.

# **RPH** issues toy buying guidelines

Christmas is a time especially for children, and for children this means toys. Each year, more than 3 billion toys and games are sold in the United States with 65 percent of these sales occurring between Thanksgiving and the day before Christmas.

Although toys are fun and educational, they can be dangerous. Poorly designed and constructed toys, or toys that are inappropriate for your child's level of development can cause serious injury, and in some cases, death.

Richland Public Health and Safe Kids USA offer the following tips and suggestions:

If there is an age warning, stick to the recommendation. Do not buy "older" toys for young children.

•Remember that young children may be especially vulnerable to choking on small parts and toys containing these should be avoided when buying for this group.

There are various things you can check on the toy:

sharp edges or hidden spikesloose facial features, wheels, tires and

other small parts: These should be securely fixed to the toy

•secure seams: if the stuffing is accessible, a child could choke on it

•any cord on a pull along toy should be at least 1.5 mm thick

•any holes or gaps into which children could put their fingers and suffer harm from the mechanical parts inside

•brittle plastic which could shatter into small sharp pieces

•folding mechanisms: How much damage would they do if a child's finger

were caught in them?

Richland Public Health cautions that items with painted surfaces may contain lead paint. Consumers should sign up to receive products recalls with the Consumer Product Safety Commission at www.cpsc.gov.
