# **OSU-M** honors three alumni during annual Hall of Fame Awards

The Ohio State University at Mansfield honored three alumni March 25 as part of its Alumni Hall of Fame Awards. The program recognizes graduates who have contributed significantly to their professions and communities.

Carrie Rietschlin Kemerer, Steven Oster and Bertha Villa Bishop were the honorees.

Carrie Rietschlin Kemerer, Class of '01, Bachelor of Arts, Psychology, is a dedicated community leader in Richland County. She completed her entire degree at the Mansfield campus.

She is the executive director of The Shelby Foundation, where she leads the strategic investment of grants to better the Shelby community. She also serves on the executive committee of the Community Improvement Corporation of Shelby, playing a key role in revitalization projects like the \$1.6 million Black Fork Commons Plaza. She is a member of the Rotary Club and acting treasurer for the United Fund of Shelby.

Kemerer has been instrumental in growing The Shelby Foundation, particularly by

spreading awareness and organizing the annual "For a Brighter Tomorrow" fundraising gala, which raises significant funds for area nonprofits. Her tireless dedication to service and ability to bring people together have made her a central figure in many transformative initiatives throughout the county.

Steven Oster, Class of '00, Master of Arts, Public Policy and Man-

agement, is a distinguished leader in developmental disabilities, serving as superintendent for the Knox and Coshocton County Boards of Developmental Disabilities and executive director for PAR — Professionals, Advocate, Resources. He completed his master's degree in public policy from Ohio State with his first year at Ohio State Mansfield.

His career includes executive roles at the Ohio Department of Developmental Disabilities, the County Board Association, and Summit County Board of DD. He has received numerous awards for his advocacy, including the

Ron Kozlowski Award and Betty Macintosh Award. Steve led the campaign to establish Harmony Park, an inclusive playground in Knox County, and holds board leadership positions in various community organizations including the Knox Chamber, Coshocton United Way and Mansfield Playhouse.

Bertha Villa Bishop, Class of '11, Bachelor of Arts, History, (B.L. Bishop), is a nationally recognized photogra-

pher in Mansfield.

She is celebrated for her exceptional talent in capturing life's most precious moments. Bertha is a native of Medellín, Colombia, and her journey in photography began with her passion for storytelling through images while pursuing a journalism degree there. After landing in Mansfield, she left her job as a Spanish teacher, returned to Ohio State Mansfield to earn a degree in history, and founded her photography business full-time.

### **MindSprouts Creative Writing** Program announces new themes

The Renaissance Education Department has introduced a fresh twist on its annual MindSprouts Creative Writing Program, part of the 2024-'25 Mechanics Bank Education Series.

Now in its 14th year, this beloved program offers a unique opportunity for students in kindergarten through 12th grade to develop their storytelling skills and see their words come to life on stage.

MindSprouts is a creative writing contest that encourages young writers to unleash their imagination through short stories, plays, and poems. Open to all K-12 students in Richland County and surrounding areas, the program provides a platform for students to express their creativity, refine their writing skills and experience the thrill of having their work performed on stage. Jason Statham stars in *A Working Man* as Levon Cade, a former military member turned construction worker.

Cade is leading a good life working while sharing joint

custody of his young daughter. Soon, his employer's daughter gets kidnapped and Cade takes it upon himself to solve the clues to try and find her.

Directed by David Ayer, director of *Training Day* and *The Fast and the Furious*, and

co-written by Sylvester Stallone, I personally had higher hopes for this movie. This turns out to be just another run of the mill kidnapping plot with the same Russian mobsters that seems to be in every movie.

Statham is fine in the lead role and the movie has some nice touches when he and the young actress who plays his daughter have scenes together though everything else, including the fight scenes, are very predictable and unmemorable.

There were times *A Working Man* was engaging with some of the characters and the movie seemed to want to flesh out

a real character for Statham though the movie gets bogged down in trying to feel like every other movie in this genre. The villains are all over the top, the fights are pretty brutal and the plot feels more direct to DVD than something that should be

in theaters.

I can see big fans of Statham really enjoying *A Working Man* for merely delivering on what it promises though maybe a little more character development, unique villains and more engaging plotline would have helped this movie go a long way.



# Next week is deadline to register to vote

The deadline to register to vote or change an address or name for the May 6, primary/special election is Monday, April 7.

The Richland County Board of Elections office will be open that evening until 9 pm. This office is located at 1495 W. Longview Ave. Suite 101 in the Longview Center.

After 4 pm, those coming to vote must use the entrance at the lower-level back parking area at the southwest corner of the building.

Qualifications for registering to vote include being either a native U. S. citizen or a naturalized U.S citizen, being a resident of Richland County and Ohio 30 days before an election and being a minimum of 18 years of age on or before the date of the general election on Nov. 4, 2025.

Registered voters who have moved or changed their name must notify the board office in writing or in person.

Voters currently registered in Ohio may change their address online at VoteOhio.gov but must do so by the April 7 deadline.


Online registration is also now available at VoteOhio.gov.

In addition to the Richland County Board of Elections office, citizens may register or complete a change of address/name at Richland County locations including any library branch, all city and village hall offices, The Bureau of Motor Vehicles office, The Department of Human Services, The Richland County Courthouse (recorder or treasurer offices) and all area high school offices.



# Construction projects announced for Richland and Ashland counties

Construction projects are anticipated to affect ODOT roadways in Richland and Ashland County. All outlined work is weather permitting and is subject to change.

State Route 13 northbound and southbound, from Hanley Rd. to Chilton Ave., will have long-term lane closures for a resurfacing project. The northbound and southbound driving lanes will be closed for roadway reconstruction and culvert work.

Traffic will be maintained in 10' lanes in each direction with barrels. Estimated completion for the 2025 construction season is November 2025. The estimated completion of entire project is May 2027

Interstate 71 northbound and southbound, between State Route 39 and U.S. 30, will have single lane closures for a slope stabilization project. Two lanes of traffic will be maintained. Estimated completion is November 2025.

State Route 181 will have single lane closures from just south of Main Street in Crestline, to State Route 309. Project work includes pavement repairs and bridge maintenance work. Traffic will be maintained by flaggers. Estimated completion is September 2025.

Beginning the week of April 7, State Route 314 from the Morrow County line to the city of Ontario corporation limits will have single lane closures for a pavement repair project. Traffic will be maintained by flaggers. Estimated completion is June 2025.

State Route 96 from State Route 545 to just east of Baney Road, will have single lane closures beginning the week of April 7 for a resurfacing project. Traffic will be maintained by flaggers. Estimated completion is September 2025.

State Route 96, between Wells Road and Township Road 1193, will close Thursday April 3 for a culvert replacement. The estimated reopening is Monday, April 7.

State Route 96, between Township Road 1443 and County Road 1353, will close Tuesday, April 8 for a culvert replacement. The estimated reopening is Friday, April 11.

# Brenner, Gavarone introduce bill to require proof of citizenship to vote

State Senator Andrew Brenner (R-Delaware) and State Senator Theresa Gavarone (R-Bowling Green) have introduced Senate Bill 153 to protect the integrity of Ohio's elections.

"Having only legal voters cast a ballot each election should be common sense," said Senator Brenner. "This bill makes sure that Ohio has fair and reliable elections so that every time a vote is cast, no one can doubt that their vote will be secure."

"Ohio is the gold standard when it comes to running elections," said Senator Gavarone. "Senate Bill 153 addresses areas of the election law we can improve, including an extra layer of protection to enforce our state constitution's citizenship requirement. This is a simple fix that strengthens trust and integrity in our institutions."

Senate Bill 153 ensures only legal citizens are voting in our elections. Citizenship must be verified upon a voter's registration or after updating their registration.

The bill also requires that the Secretary of State regularly review statewide voter rolls to identify potential non-citizens. The bill also bans the use of drop boxes.

After introducing this legislation, President Trump issued an Executive Order that mirrors SB 153 in many ways. "I was very excited to see President Trump's Executive Order closely aligns with the work we have done in Ohio and the work we will continue with Senate Bill 153," said Senator Gavarone.

The legislation has been referred to the Senate General Government Committee for further consideration.

# Ohio gained the most jobs of any state in the U.S.

In its monthly State Employment and Unemployment News Release, the U.S. Bureau of Labor Statistics announced that Ohio employment increased more than any other state in the nation in February 2025.

"These numbers are great news for our state," said Ohio Chamber President & CEO Steve Stivers. "The Ohio business community has been laser-focused on economic development – with JobsOhio leading the charge – and the results are showing. More jobs mean a stronger economy, as well as more and better opportunities for all Ohioans."

The report states that nonfarm payroll employment increased in three states last month and remained largely stagnant in 47 states and the District of Columbia. Job gains occurred in Ohio, New Jersey and Missouri.

Nonfarm payroll employment measures the number of paid workers in the state, excluding farm workers, private household employees, nonprofit employees and actively serving military.

Throughout the month, jobs in Ohio increased by 23,100, a 0.4% increase from January. This is the largest increase Ohio has seen since July 2022.

### Balderson, Kelly reintroduce bill to prevent prescription opioid abuse

Congressman Troy Balderson (OH-12) and Congresswoman Robin Kelly (IL-2) reintroduced the Remote Opioid Monitoring Act to empower health care providers and combat opioid abuse. This legislation directs the federal government to study the benefits and effectiveness of remote monitoring technology, which would help health care providers track patients prescribed opioids and ensure their well-being.

"The opioid epidemic has devastated communities and families in Ohio and across the country," said Balderson. "To combat this crisis, we must allow doctors to intervene early and prevent prescription abuse and misuse from the outset. This legislation empowers health care professionals to oversee their patients' treatment and monitor how they respond to prescribed medication."

In 2023, opioids claimed the lives of 105,007 Americans, including 4,452 Ohioans who died from an unintentional opioid overdose. For many Americans, their first exposure to opioids comes from a prescription from their physician. Some patients develop an addiction, whether through proper use or misuse.

Improving prescription monitoring has been identified by experts as a key component in the fight against the opioid epidemic. Detecting troubling signs during a prescription regimen allows health care providers to intervene early.

The Remote Opioid Monitoring Act would require the Comptroller General of the United States to study the remote monitoring of

patients prescribed opioids. The study would assess the efficacy of remote monitoring programs, examine their prevalence, and provide recommendations for improving existing federal health care programs.

This legislation passed the House last Congress by a vote of 386-37 when it was included as part of the Support for Patients and Communities Reauthorization Act, which focused on equipping communities to combat substance abuse.

# Kenpo Instructor Jason Farnsworth achieves 7th-degree black belt

Jason Farnsworth, Kenpo Martial Arts instructor at Richland Academy of the Arts, earned his 7th-degree black belt under the guidance of Joe Doyle and Grandmaster Huk Planas. The promotion took place following an intensive seminar at Doyle's studio in Mentor, OH, where Planas has been teaching since 1999.

Doyle set out to cover the entire Kenpo curriculum one technique and form at a time — a challenge Planas once deemed impossible. Through years of dedication and four annual seminars, the full self-defense curriculum was completed by 2006, leading to a second and now a third cycle. Doyle's school remains the only one in the world to achieve this milestone.

Ater hours of training, Doyle stood before a group, reflecting on this journey. He then called Jason Farnsworth and Al Babinec (of Strongsville) to the front, where Planas, now 78 and still traveling the world teaching Kenpo, recognized their dedication promoting them to 7th-degree black belt.

"In my lifetime, this was never a goal — never on my list of things to do," said Farnsworth. "The responsibility, knowledge and technical background that come with this are overwhelming. Honestly, I'm still processing it. My focus has always been, and always will be, on passing this knowledge down to the next generation — helping my students build confidence in themselves, master their skills, and ensure the legacy of Kenpo continues long after me."

### Pond fish sale orders accepted

The Richland Soil and Water Conservation District (Richland SWCD) has announced orders are being accepted for the pond fish sale until April 17.

Customers can select from bluegill, \$1.25 each; yellow perch, \$1.25 each; largemouth bass, \$1.50 each; fathead minnows, \$8.25 per 100; channell catfish, \$1.25 each; hybrid bluegill, \$1.25 each; redear bluegill, \$1.25 each; and white amur, \$16 each.

In addition to fish, customers may also purchase essential pond supplies including Pond conditioner, prices vary; optimal fish food, \$48; and plastic bag and tie, \$1 each.

Orders may be placed online at https://richlandswcd.net/event/pond-fish-sale-order-deadline-2/. A minimum order of \$20 is required.

Pick-up for all orders will take place at the Richland County Fair-grounds Horse Barn on April 25 from 10 to 11:30 am. Customers should bring appropriate containers to transport their fish safely. Five-gallon buckets work well but must have an unscented poly liner to ensure fish have enough oxygen during transportation. Customers should also have their containers filled one-third full with the pond water the fish will be transferred into.

### **Kindergarten registration underway at Madison Schools**

Kindergarten registration for Madison Local Schools is being held now through April 30. Children are eligible to attend kindergarten during the 2025–'26 school year if they are five years of age on or before Aug. 1, 2025.

The first step in the registration process is to complete the online registration through FinalForms. The registration link can be found at www.mlsd.net under Madison FinalForms or use the link under Kindergarten Registration.

Those who do not have internet access or need help can schedule an appointment to complete the online forms with their child's assigned building. Students must register with their assigned building. Be sure to select the 2025–'26 school year in FinalForms when registering a child.

Open enrollment for the 2025–'26 school year will open May 1 and close May 30. Those who are not a Madison resident will need to register with their home district until they have been accepted for open enrollment. If applying for Intra-District open enrollment, parents or guardians must register with their assigned elementary school building.

Current Madison South Preschool students moving into kindergarten will need to log into FinalForms and complete the 2025–'26 forms. They should also reach out to their assigned elementary building.

Once all online forms are completed, those registering should drop off the required documents with the elementary school in which the student resides between 9 am and 3 pm, Monday through Friday. The district is on spring break from April 18–25, and elementary Schools will be closed during this time. School contact numbers are Madison South Elementary, 419-522-4319; Mifflin Elementary, 419-589-6517; and Eastview Elementary, 419-589-7335.

Required documents include student birth certificate, parent/guardian driver's license, custody papers (if applicable) which must be date stamped and signed by the court, parent/guardian proof of residency (see FinalForms for approved list) and immunization records.

Required immunizations for school attendance are four doses of DPT (five doses if four were given before fourth birthday); three or more doses of Polio with final dose after fourth birthday; three doses of Hepatitis B, two MMRs and two Varivax (Chicken Pox) or history of having disease.

# Hometown Hero: Taylor Huff playing for Bay FC

We have another Hometown Hero to bring you. If you ask some young athletes these days, many would say they have a dream to play professionally.

Taylor Huff, a 2021 Madison Comprehensive High School graduate, is living that dream. She signed to play soccer with Bay FC in San Jose, California, through 2027.

"Our season just started and goes through November, resulting in a nine-month season. High school was only a few months and college is typically four or five months. We have 26 games, but they are more spread out because it's at a higher level."

"We have one game a week on Friday, Saturday or Sunday and we have one day off each week. It's usually the same day every week

"The Bay FC is in the National Women's Soccer League and it's been kind of a whirlwind traveling these last few months. It's exciting, though.'

'It's amazing that I get to do this as a job — it's the coolest thing ever and it is what I've dreamed of."

Reflecting on her high school years, she commented that even during the pandemic, her soccer team was still able to play their matches.

Some people think wearing the number 13 might be bad luck, but Huff displayed it proudly on her jersey. While donning that number she had some impressive stats and Madison even retired her number in honor of her accomplishments.

While at Madison she was a four-time All-American and held a record of 75–6–10. She was named Division II Player of the Year and

Ohio Ms. Soccer, Gatorade Ohio Player of the Year in 2020.

Taylor led Madison to the first-ever OHSAA State Championship in 2020 and broke Madison's OHSAA record with 133 career goals and 93 assists. Taylor also graduated class valedictorian with a 4.0 grade point average.

In addition to playing for the Rams, she gained experience playing club soccer.

I played for the Mansfield Crew growing up. It was a local club in Mansfield that my dad helped start. Then my parents started taking me to Cleveland for the Internationals Soccer Club and I ended up playing in the East Clubs National League games.'

"I loved playing for the International Soccer Club and was an athlete there from seventh grade until I graduated from high school."

This is where younger kids play competitively and college coaches will come and scout at the big tournaments. I tried not to focus on the fact they were there and just focused on playing.

"We knew ahead of time that a group would be coming in and afterwards, they would send athletes a letter."

During her college years, Taylor was a three-time All-American.

"I knew I wanted to attend a competitive college and I attended The University of Tennessee before attending and graduating from Florida State University".

"When I was younger I had no idea what I wanted, but I am thankful for the guidance that I had from both my parents and my coaches.'

"At Tennessee, I had a great coach, Brian Pensky. He ended up leaving to coach at Florida State University, where I later transferred.

"While playing for Florida State, we won a national championship in 2023.'

While at college Taylor was an USWNT Futures Camp Invitee in 2025, Three Time All-American, First Team All-ACC in 2024, NCAA National Champion in 2023, NCAA All-Tournament Team in 2023 and U-23 USWNT Selection in 2023.

When asked how she prepared for a life in professional sports Taylor said, "We do a lot of mental training. There are many things you have to stay up to date with including in the training room and on the field.'

'Mental training continues as you get older. As I continue into my career as a professional, it is my job. I think it becomes even more important to do mental training and I always need to make sure that I am staying positive and doing the right things."

"It can be hard, but when I'm staying on top of my training, the (Continued on Page 15)

pressure is relieved. I'm able to play at my best. You can revert back to that solid foundation of training all the time."

As her professional career continues, she will not have much free time to visit family due to traveling to play all over the United States. "I'll probably come home once or twice during the year."


"I enjoy San Francisco and it has a lot of different food options. I live in a pretty decent area, so it's always good to try new foods, but I cook a decent amount, too."
